

### 7 Species & Snapper Tournament 2020 Rules

#### Rules

- 1. DATE Saturday 7th November 2020
- 2 Tide High water 12:15
- 3. START TIME:

All Boats entered in this tournament cannot depart until 06:00 on Saturday 7th November 2020, and all boats entered **must** depart and return over the Whakatane Bar. Tournament will end at 17:00 Saturday 7th November 2020 which is the final weigh in time.

#### 4. REGISTRATION:

A minimum of 2 anglers per team. All competitors must be members or (have paid the appropriate social/nonmember membership fee) of the Whakatane Sportfishing Club. Registration will be taken in the clubrooms from 17:00 Friday 6th November 2020 or at the discretion of the Tournament Convenor or Tournament Committee.

For anglers to be added to already registered teams, there is a box at the weigh station where angler's details and the correct fees can be deposited **"PRIOR TO DEPARTING"**. This box will be cleared prior to the weigh in time. The Whakatane Sport Fishing Club reserves the right to refuse entry.

YOUR CLUB MEMBERSHIP NUMBER MUST ACCOMPANY REGISTRATION.

#### 5. BRIEFING:

There will be a briefing in the clubrooms at 19:00 on Friday 6th November 2020. The Skipper <u>or</u> a nominated "fishing" team member must attend the briefing and at the completion of the briefing sign the briefing attendance sheet.

#### 6. ENTRY FEES:

Entry fee for full financial members is \$30.00 per angler. Social & non-members must pay the additional social/nonmember membership fee of \$20.00 plus the entry fee of \$30.00.

#### 7. SPECIES:

Snapper, Mau Mau, Trevally, Tarakihi, Kahawai, Red Gurnard, John Dory.

#### 8. MINIMUM FISH WEIGHT/LENGTH:

Snapper 1-15kg line class must exceed 40cm

Kahawai 1-15kg line class

Trevally 1-15kg line class must exceed 25cm
Tarakihi must exceed 25cm
Red Gurnard must exceed 25cm

#### 9. TACKLE

Fish may only be caught on rod & reel. Electric reels cannot be used in any club tournaments. Braid line: Any fish caught with braid line will not be eligible for any club records, certificates, pins points or club trophies.

#### 10. WEIGHING OF FISH

Weighing of fish commences at **14:00 Saturday 7<sup>th</sup> November 2020**, all fish weighed must be freshly caught, brought across the Whakatane Bar, and weighed from the vessel (unless stated otherwise) at the weigh station. Final weigh in time is **17:00 Saturday 7th November 2020**.

In the event of 2 or more fish being equal in weight a live draw will be undertaken at prize giving to determine the heavier fish.

#### 11.PRIZES

Team prizes will be a maximum of 4 per team and will be awarded to the following categories:

#### Section 1.

For team prizes - 1st through to 10th.

To qualify for the team prize you must have 5, 6 or 7 of the seven species. Prizes will be awarded in the first instance to the team catching the most species, and then in order of the heaviest combined weight. E.g.  $1^{st}-7$  species @ 15kg

2<sup>nd</sup> – 7 species @ 12kg 3<sup>rd</sup> – 6 species @ 20kg

Team to only weigh their heaviest of each of the listed species.

Section 2. (One prize per angler in this section.)

1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> Prizes will be awarded for the heaviest Snapper for Men, Ladies and Juniors.

Average Snapper weight for Men, Ladies and Juniors.

Section 3.

The hard luck prize is for the team that does not weigh in 5, 6 or 7 of the 7 species. (Note: All teams who did not weigh in 5,6 or 7 of the 7 species will go in this draw.

Also Note: all members of the team must be present to collect this prize.)

#### **12. PRIZE GIVING**

Prize giving will be held in the clubrooms, from 19:00 on Saturday 7th November 2020. **The winner of a prize OR a fishing member from the same team must be present** to collect the prize, (sections 1 and 2) unless the Tournament Committee have been advised of any problem by 18:30 Saturday 7th November 2020 and dispensation has been granted.

#### **13 COMPLAINTS**

Any complaints regarding this tournament will be in the first instance directed to the Tournament Convenor, the Tournament Committee will then consider the dispute. Any complaint <u>must</u> be submitted in writing. **The decision of the Tournament Committee** is final and binding. Angler entry constitutes agreement to this process.

Any concern relating to the weighing of fish must be brought to the attention of the Weigh Master **before** the angler leaves the weigh station.

#### **14** CANCELLATION OR POSTPONEMENT

The Tournament Committee reserves the right to abandon or postpone the tournament for any reason. This information will be broadcast on Radio IXX prior to start time or as soon as possible after a decision has been made.

#### **15 DISCLAIMER**

All participants involved with this tournament do so at their own risk. The team skipper shall be responsible for the safety and other considerations of self, crew & boat. The Whakatane Sportfishing Club (Inc) accepts no responsibility.

16 ANY PERSON OR TEAM NOT ABIDING WITH THE ABOVE RULES WILL BE DISQUALIFIED.



#### IMPORTANT NOTICE TO ALL TEAMS:

#### SAFETY RULES FOR THE WHAKATANE SPORTSFISHING CLUB.

- (1) All skippers or a nominated "fishing" team member must attend the briefing. The briefing will be held at 19:00 Friday 6th November 2020.
  Attendance to this briefing is compulsory and no team can compete in this tournament until the skipper or nominated "fishing" team member has attended the briefing and once the briefing is completed, sign the briefing attendance sheet.
- (2) There must be a minimum of two (2) persons on the vessel, and at least one of the persons should be over the age of 18 years.
- (3) It shall be the responsibility of the skipper or the nominated "fishing' team member to advise his/her other team members of the information given at the briefing.
- (4) In the interest of safety, the Tournament Committee reserves the right to alter all times for the duration of the Tournament depending on the weather or sea conditions.
- (5) In the event of an emergency on the water, participants are to notify the Whakatane Coastguard on VHF channel 18.
- (6) All boats must carry correct size Life Jackets for all passengers. It is compulsory for all crew members on recreational vessels to wear Life jackets while crossing the Whakatane River Bar.
- (7) All participants agree and accept -
  - (a) To enter this Tournament at their own risk,
  - (b) That boating and fishing involves a risk
  - (c) Not to hold Tournament organizers, Officials, Sponsors, or any other person involved with the Tournament liable for any loss or injury to person or equipment incurred during the Tournament,
  - (d) Notwithstanding any representations made, it shall be the responsibility of all participants to ensure that the provisions of all statutes, ordinances, regulations and by-laws related to (but not limited) to boating and fishing are complied with.
  - (e) All participants agree to have read and understood the Tournament Rules.

#### SKIPPERS RESPONSIBILITY

I have the necessary skill, knowledge, and qualifications to safeguard all on board.

My vessel and all equipment are properly maintained.

We have a minimum of two means of communications, i.e. VHF marine radio, cell phone, flares.

My passengers are briefed on the location and use of all safety equipment.
